GENERAL INSTRUCTIONS

DuPont Advion cockroach gel is designed to control pest species of cockroaches including German and American. The slight delay in mortality caused by the active ingredient, Indoxacarb, allows cockroaches to consume the bait and return to the harbourage site to contaminate other cockroaches resulting in significant reduction in infestation levels.

Use Instructions and Precautions

- 1. Advion cockroach gel should be applied to areas frequented by cockroaches such as between different elements of construction, between equipment and floors, openings leading into voids and hollow spaces in floors, walls, ceilings, equipment legs and bases, around plumbing pipes, doors and windows, and behind and under appliances, cabinets, sinks, closets, and any other equipment that cockroaches are typically known to hide.
- 2. Avoid applying Advion cockroach gel to surfaces recently treated with residual sprays.
- 3. Surfaces treated with Advion cockroach gel should not be treated with residual sprays.
- 4. Repeat applications may be made upon inspection during follow-up inspections of the treated areas.
- 5. **DO NOT** apply to surfaces that food contacts.
- 6. DO NOT allow open foods to contact gel material.

To apply the gel, remove the cap on the nozzle and touch the tip to the surface to be treated and slowly depress plunger until sufficient gel is dispensed. Recap the dispenser after treatment is completed.
