RESTRAINTS

DO only apply PESTIGAS™ with CIG approved equipment.

For manual spray use either

a) kit 736635 and 736685 nozzle

b) Spray gun 736679 fitted with 736685 nozzle. Dose cylinder 736688 and Pestigas[™] Fill Connector 73 100 l.

For fixed spray installations refer to CIG for approved pest control systems using programmed time release or manual release.
